In community empowerment itself, there are several principles, including the principle of equality in which the position between the community and institutions that carry out community empowerment programs has an equal relationship by developing mechanisms for sharing knowledge, experience, and expertise. The principle of participation that can stimulate community independence, is planning, implementing, monitoring, and evaluating the community itself up to the level of the mentoring process that involves assistants who are highly committed to community empowerment. The self-reliance program is the ability to save in-depth knowledge about business constraints, as well as knowing the condition of the environment whether it has a workforce and willingness and societal norms. The last is the sustainable principle, which means that the empowerment program is designed in such a way, in stages, to be able to provide understanding, knowledge, experience, and skills to each individual.¹

The implementation of this economic system in Indonesia relies on full control in society which has an active role in production, distribution, as well as consumption. This is very influential on the control constraints of the modern economy.
