Abstract

Symbolic violence is a form of violence that occurs through language, symbols, or actions that demean, discriminate, or exploit a person or group. Preventing symbolic violence can be done by increasing awareness about symbolic violence and its impact on society, respecting diversity and avoiding stereotypes that demean or discriminate against certain groups, encouraging critical thinking and self-reflection in individuals and groups to avoid actions or speech that can cause symbolic violence, develop policies that are inclusive and respect diversity in educational environments, workplaces and communities. For this reason, it is necessary to collaborate between service members who are lecturers at Singaperbangsa University Karawang and students of SMA 1 Teluk Jambe in Karawang Regency which aims to identify symbolic violence that occurs in society and socialize the Anti-Symbolic Violence Movement through the Snake and Ladder Game. INTRODUCTION

Symbolic violence in Karawang Regency covers the complexity of conflict and violence in various contexts, including trigger factors, impacts and efforts to handle them. Several findings relevant to symbolic violence in Karawang Regency include (Silveira et al., 2019):

- 1. Dominant conflict trigger factors, such as economic factors in the struggle for economically valuable resources
- 2. Cases of agricultural land disputes and agrarian conflicts involving farmers and local governments, as well as alleged indications of collaboration between the government and certain parties that are not pro-people
- 3. The complexity of domestic violence which involves various forms of violence, including physical, psychological and sexual violence
- 4. Conditions of violence that have become a concern in the educational context, such as symbolic violence in schools

Against this background, an in-depth understanding of the local context, conflict dynamics and the impact of symbolic violence in Karawang Regency is important in formulating effective preventive and intervention measures. Apart from that, collaboration between various parties, including the government, community institutions and educational institutions, is also needed to overcome the complexity of problems related to symbolic violence in this region (Novarisa, 2019).

Several factors that influence symbolic violence in Karawang Regency include the struggle for economic resources, social interactions in the school environment, and socioeconomic factors. The research results show that the most dominant trigger for conflict in Karawang Regency is economic factors, such as fighting over waste that has economic value. Apart from that, symbolic violence also occurs in the school environment, where social interactions between poor students can be the beginning of symbolic violence. Furthermore, socio-economic factors also influence the occurrence of violence, such as in cases of sexual violence against children (Nadhira Diva Saraswati, 2022). Therefore, an in-depth understanding of these factors is very important in efforts to prevent and deal with symbolic violence in Karawang Regency.

Several factors influence sexual violence against children in Karawang Regency including environmental factors, the influence of mass media, social factors, and economic factors. Research shows that environmental factors and the influence of mass media can influence the occurrence of sexual violence against children. Apart from that, social and economic factors also play a role, such as vulnerable socio-economic conditions and psychological factors. Social factors that influence sexual violence against children in Karawang Regency include stigma and shame, the environment, the influence of mass media, and social interactions in the school environment (Lusasi & Mwaseba, 2020). Victims often feel ashamed and consider sexual violence a disgrace, regardless of the gender of the perpetrator. The environment and influence of mass media can also influence the occurrence of sexual violence against children. In addition, social interactions in the school environment, especially between poor students, can also be a factor that influences sexual violence. Therefore, an in-depth understanding of these social factors is important in efforts to prevent and handle sexual violence against children in Karawang Regency.

The Government of the Republic of Indonesia has taken various measures to protect society from symbolic violence through policies and efforts aimed at changing norms, values and behavior that support symbolic violence. Some steps you can take include:

Service members from Singaperbangsa University Karawang will be assisted by students to align the government's program, namely independent learning, independent campus where students and lecturers carry out activities outside the campus, elaborating on theories and material obtained in college with phenomena existing in society in order to change people's behavior and knowledge regarding violence. Symbolic violence. It is hoped that collaboration with early childhood education teachers will increase teachers' knowledge about symbolic violence and bring this knowledge to the community, especially children, through the snakes and ladders game. The aim of this community service activity is expected to raise public awareness from an early age about the negative impacts of

symbolic violence in society.

IMPLEMENTATION METHOD

Priority issues that must be resolved immediately regarding symbolic violence in Indonesia are becoming increasingly important issues to discuss. Symbolic violence is a form of violence that is often overlooked, but can have a significant impact on victims (Brilhante & Jorge, 2020). Symbolic violence can take many forms, such as sexual harassment, discrimination, and stereotyping. Therefore, efforts are needed to overcome the problem of symbolic violence in Indonesia. One step that can be taken is through community service activities.  - Conduct outreach to students, teachers and parents about the importance of recognizing and preventing symbolic violence.
 - Use easy-to-understand approaches, such as stories, images, or short videos.
 - Explain the concept of symbolic violence and its impact on victims.
- 4. Snakes and Ladders Game
 - Choose the snakes and ladders game as a fun learning medium.
 - Create a snakes and ladders board with boxes containing symbolic anti-violence messages.
 - Invite students to play snakes and ladders and discuss the messages that appear in each box.
 - Also discuss actions that can be taken to prevent symbolic violence.
- 5. Reflection and Evaluation
 - After the activity, reflect with the participants about what they have learned.
 - Evaluate the effectiveness of this method in increasing students' understanding of symbolic violence.
 - Obtain input from participants to improve future activities.
- 6. Distribution of Results

- Share the results of activities with the school community and parents.
- Create a report containing a summary of activities, photos and conclusions obtained.

CONCLUSION

This outreach activity aims to increase awareness and understanding of teenagers in Karawang Regency about symbolic violence and how to prevent it. The method used is the snakes and ladders game, which was chosen because it is interactive and fun, so it can attract teenagers' interest in learning.
