- f. Learners must be ready to acquire the points being taught
- g. Materials should expose the learners to language in authentic use.
- h. The learners attention should be drawn to linguistic features of the input
- Materials should provide the learners with opportunities to use the target language to achieve communicative purposes
- Materials should take into account that the positive effect of instruction are usually delayed
- k. Materials should take into account that learners differ in learning styles
- 1. Materials should take into account that learners differ in affective attitudes
- m. Materials should permit a silent period at the beginning of instruction
- n. Materials should maximize learning potential by encouraging intellectual, aesthetic and emotional involvement which stimulates both right- and left-brain activities
- o. Materials should not rely too much on controlled practice
- Materials should provide opportunities for outcome feedback.

The studies that have been analyzing and concluding about the findings from several articles, one of them shows that teachers perceptions contribute significantly in influencing teachers' decision making in the classroom related to the choice of learning and activities for student. It means that teacher perceptions are very influential in determining the best decisions in the learning process in the classroom.
