On the document upload page on the visa-online.imigrasi.go.id, there is information about the size and types of documents that can be uploaded. If there are problems, such as scanned results that are compressed to blurry, you should use a scan tool or alternative scan application. In addition, the choice of the type of smartphone device used to perform the scan can also affect the size and clarity of the scan results.

Regarding supplementary documents, Visa applicants need to note that the application consists of Required Documents and Supplementary Documents. Although there is a view that additional documents are not crucial if all mandatory documents have been uploaded, this is not entirely true. In certain situations, such as during the COVID-19 pandemic, there may be additional document requirements that arise by the regulations of the time. In such cases, such additional requirements must be met.

Errors also often appear in certain types of Visa extension applications, such as the application for a family unification limited stay visa (C317). It should be remembered that not all family members can apply for Vitas C317.
